**MEETING MINUTES**

**APRIL 20, 2009**

President Kelly Chandler called the meeting to order at 5:45pm in the School Cafeteria. The meeting was opened with the Pledge of Allegiance, Pledge to the Texas Flag and a moment of silence.

Everyone present signed in and was given the Agenda and Treasurer's Report.

Kelly Chandler read the minutes from the last meeting on March 9<sup>th</sup>. A motion was made by Randy Meyer and seconded by Tana Jalufka to accept the minutes as read. Motion carried.

Kelly also gave the Treasurer's report and stated the current balance of the Money Market account is \$26,402.16 and the current balance of the checking account is \$403.86. A motion was made by Tana Jalufka and seconded by Jennifer Pohler to accept the treasurer's report. Motion carried.

Mr. Meyer, in the principal's report stated everything going "so far so good". The final newsletter of the year will be going out listing all of May's activities.

Under New Business:

- 1) Officers elected at last meeting for 2009-2010 are as follows: Kelly Chandler – President; Eric Nelson – Vice President; Sharla Pohl – Secretary; Tammy Brasher – Treasurer and Jennifer Pohler Parliamentarian.
- 2) Teacher Appreciation Week – is May 4<sup>th</sup> through 8<sup>th</sup>. So far we have Harley's providing lunch on the 5<sup>th</sup>; everyone agreed to bring snack trays throughout the week. We will get letter our ASAP to supply snacks as needed.
- 3) Tana Jalufka went over the proposed budget for 2009-2010 school year. There will be 134 students enrolled next year. Most budget items remained the same. Those that will be increased are AR Store – up to \$1000.00; Field Trips – up to \$945.00; and School Improvements – up to \$6,000.00. These are a total addition of \$2,175.00 to the budget. Therefore the total budget will be \$12,632.50. Tana Jalufka made a motion to accept the 2009-2010 budget as presented, Theresa Kristek seconded the motion and motion carried.
- 4) In discussing the amount to be given to scholarship fund for each student, it was determined there were 123 eligible students. The amount eligible to be divided is \$7,272.80 and it was discussed as to whether to give each student \$55.00 - \$6,765.00 or \$60.00 - \$7,380.00. A motion was made by Denise Raz to credit each 123 student with \$55.00 to the scholarship account. This motion was seconded by Jennifer Pohler and motion carried.

There were no communications not requiring action.

Therefore with there being no further business, the meeting was adjourned at 6:05p.m.
